29 May 2024: THE PAX CHRISTI INTERNATIONAL COMMUNITY CRIES OUT AND ASKS ...

Is there a prayer we can utter that can possibly express the depth of pain and despair we feel as we witness the unbearable suffering of our sisters and brothers in Rafah? We tremble in the face of such horror and disregard for the sanctity of life. Is our voice loud enough to shake the heavens or better yet is our voice determined enough to shake those on earth? When will justice be served so that peace can be realised? We lift our eyes for we can no longer look at what is in front of us. And plead to the God of love, mercy, and forgiveness. Strengthen our resolve to never avert our eyes, to remain steadfast in our witness. Shield us from what is surely a righteous anger and instead plant seeds of hope in our hearts. Make us your agents to turn swords into ploughshares.

We plead with all faith leaders to forcefully condemn the IDF attacks in Rafah which have caused so much suffering and demand that Israel respect international and humanitarian law and abide by the recent ICJ rulings. We demand a permanent and immediate ceasefire to allow the start of diplomatic negotiations. These massacres must stop immediately, and critical humanitarian aid must not only be allowed to cross into Gaza without delay but its safe delivery secured by the occupation forces.

Dear G7 Heads of Government, on behalf of over 160 Israeli and Palestinian peacebuilding organizations that make up the Alliance for Middle East Peace (ALLMEP), and others who stand in solidarity with this community, we write to you today to urge you to include language in the upcoming G7 Leaders' communique highlighting the importance of civil society peacebuilding work as an integral part of any viable process to end the Israeli/Palestinian conflict.

With levels of violence, trauma and destruction that we have never before seen, we are calling on you to address the Israeli/Palestinian conflict in a more comprehensive way than we have seen attempted previously.

As long-time advocates of peace, we see the recent horrific, yet avoidable, escalation of violent conflict as a clear indication of the international community's failure to adequately support civil society peacebuilding initiatives. Thanks to successive academic studies, we know that such programs – which build meaningful relationships between Israelis and Palestinians and are predicated on a shared commitment to peace, security and equality for both peoples – disrupt and reverse attitudes and beliefs that fuel conflict.

For peace to last it must be built from the ground-up. Yet, every previous round of Israeli-Palestinian diplomacy has lacked a "bottom-up" strategy. To ensure the success of any diplomatic initiative, top-down negotiations among leaders must be matched this time by a peacebuilding process at the societal level between Israelis and Palestinians, even more critical now considering the trauma and polarization from the unprecedented violence of past months.

As such, we – Israeli and Palestinian civil society peacebuilders, and our partners around the world – are recommending that the Apulia Summit break new ground on multilateral support and a new centrality for civil society peacebuilding – a consensus priority not dependent on the more complex issues currently being debated and creating division and delay. Specifically, we recommend that G7 leaders include language in the Leaders' Communique that commits G7 states and other welcome partners to collaborate on civil society peacebuilding as part of a coordinated and multilateral approach to conflict resolution. Specifically, we recommend the insertion of the language below, which aligns the G7 with the latest messaging within the Quartet, UN, and several G7 member states: "We affirm our commitment to working together multilaterally – and with other international partners – to closely coordinate and institutionalize our support for civil society peacebuilding efforts. Ensuring that such efforts are part of a larger strategy to build the foundations necessary for a negotiated and lasting Israeli-Palestinian peace"

There can be no sustainable peace without the critical mass of individuals and groups in Israel and Palestine who can support and sustain a diplomatic agreement. We welcome your reply and commitment to supporting peace and Israeli-Palestinian partnership.

UN COURT RULING FOR ISRAEL TO STOP RAFAH OFFENSIVE 'MUST BE IMPLEMENTED IMMEDIATELY'

Source: Christian Aid 26 May 2024: The international development agency Christian Aid says all states should get behind the UN's International Court of Justice's (ICJ) decision that Israel must halt its military offensive in Rafah in southern Gaza. The ruling follows South Africa's petition to the ICJ for emergency measures, to order Israel to halt all operations that threaten the survival of the Palestinian people.

IOPT Programme Manager at Christian Aid, Julie Mehigan, said: "In its ruling the ICJ has demonstrated at last that the international rules-based order can work for the protection of Palestinian civilians. The order to halt military actions in Rafah needs to be implemented immediately. Crossings need to be opened so that aid can be delivered to starving people at scale. All states must get behind the ruling and take whatever measures are necessary to ensure it is upheld. After almost eight months of terror our partners along with all Palestinian civilians and the hostages in Gaza deserve nothing less."

The International Criminal Court's (ICC) chief prosecutor asked the court's judges earlier this week to approve the arrest warrants of Israel's Prime Minister Benjamin Netanyahu and Hamas leader Yahya Sinwar for war crimes and crimes against humanity. Tonight, Husam Zomlot, Ambassador of the State of Palestine to the UK, has written on X (formerly Twitter): "Israel commits a massacre in #Rafah this evening, dropping several 2,000 pound bombs on civilian tents and #UN compounds, murdering dozens of civilians seeking shelter. This was Israel's response to the @CIJ_ICJ ruling Friday that it must halt its offensive on Rafah."

Mustafa Barghouti, Palestinian doctor and politician writes: "Horrible scenes of a new massacre in Rafah: The Israeli army committed a horrific massacre in North West Rafah which is supposed to be a safe area bombarding and burning tents of displaced Palestinians killing more than 30 civilians many of whom were burned to death and injuring many others." <u>https://www.indcatholicnews.com/news/49852</u>

BALFOUR PROJECT CONFERENCE TO CALL FOR UK RECOGNITION OF PALESTINE

27 May 2024: UK recognition of Palestine is one of a number of actions for the UK Government to be discussed at the Balfour Project conference **'Peace with Justice - how to get there'** from 2pm UK time, on Thursday 6 June 2024 at Bush House KCL and online: <u>https://balfourproject.org/2024conference/</u>

The conference organisers state: "The people of Gaza have been subjected to a level of death, injury and destruction surpassing all previous cycles of violence, and now face man-made famine. The West Bank is locked down, its economy at a standstill, while settler violence goes unpunished. The people of Israel suffer from the lasting horror of the 7 October Hamas attack, their fear for the hostages still captive, and the wider regional threat. Despite a growing international consensus pressing for an end to the conflict, the dreadful prospect of further escalation in Gaza is real.

"On 6 June, in partnership with the History Dept of King's College London, the Balfour Project is bringing together a range of speakers with ideas on the pathways out of this dreadful calamity towards Peace with Justice for both peoples. Palestinians will provide eye-witness accounts, insight and fresh thinking; other speakers will cover the regional and international context. There will be a Q &A with MPs focused on what actions the British Government should take to advance equality under the law."

LIKE IRELAND AND MORE THAN 140 OTHER COUNTRIES, IT IS TIME THE UK RECOGNISED THE STATE OF PALESTINE

Sir Vincent Fean writes in The Independent online newspaper 27 May 2024:

For more than a century, Britain has shown scant respect for Palestinian rights, says our former envoy in Jerusalem, Sir Vincent Fean – we must now play our part in creating a framework for peace.

Palestinian self-determination is the key to a just peace in the Middle East. The United Kingdom deprived Palestinians of that right, through its misconduct of the Palestine Mandate, before we cut and ran in 1948. It is 57 years since the Israeli occupation of Gaza, East Jerusalem and the rest of the West Bank. It is only right that we should now recognise the state of Palestine on those lands.

Spain, Ireland and Norway are the latest to have done just that, last week announcing that, from tomorrow, they will join the long list of countries that formally recognise a Palestinian state. They have set the example that the United Kingdom should have provided for the so-called two-state solution – and which we must encourage others to follow.

First, some clarity is needed on what we should envisage as the Palestinian state: namely, pre-June 1967 borders, with full territorial sovereignty, the free movement of people and goods, and control of administrative matters (a registry of births, and so on).

Security is fundamental to statehood. In January, Foreign Secretary David Cameron said that the last 30 years had been a story of failure for Israel because it had not delivered that basic security requirement to its citizens. And the reason for that failure is that Netanyahu and his peers have systematically deprived Palestinians of their rights – including their own right to security – by entrenched military occupation, blockades, the building of illegal settlements and much more besides.

The realisation that my safety is best assured by the safety of my neighbour, through mutual security with international guarantees, is what will stop this chronic cycle of violence. Repression is not only evil – it doesn't work.

The arguments presented against state recognition for Palestine now are spurious. To confirm its status alongside Israel is not a "reward for terror", as Netanyahu claimed last week, adding that a sovereign Palestine would be a "terror state" that would "try to repeatedly carry out the massacre of 7 October".

Yet some 140 governments, out of the 193 UN member states, now recognise the state of Palestine – and our Government recognises states, not their governments, an important distinction. There will be no recognition for Hamas, for Fatah, or for any other faction. If Hamas seeks to wipe Israel off the map, it only stands to lose when states reaffirm their recognition of Israel along pre-June 1967 lines. British recognition of Israel has been a fact for over 70 years and is completely unaffected by recognition of Palestine.

Nor is British recognition of Palestine "premature". It is decades overdue. MPs voted overwhelmingly for recognition ten years ago. Since 2011, our Government's policy has been to recognise the state of Palestine "at a time of our own choosing, when it will best advance the cause of peace". That time is now.

It is wrong to subordinate recognition to potential peace negotiations. The current Israeli administration asserts that it has the right to all of the land between the Mediterranean Sea and the Jordan River. Netanyahu's coalition agreement explicitly states that only Jews are entitled to self-determination on that land – a racially defined claim. While he remains in office, there will be no negotiations. The prospects thereafter are, at best, uncertain.

It is for the UN Security Council, working with regional partners, to create the framework in which peace with justice can come about. In 1948, Britain sought to wash its hands and transfer its historic responsibility to the United Nations. The UK retains a duty to do better. The inauspicious days as the Mandate Power are long gone, but Britain still has influence to exert, for good or ill.

The United Kingdom is a permanent member of the UN Security Council, alongside France, now the leading foreign policy player in the European Union. The UK should work closely with France, the US, EU, Israel's Arab neighbours and those Commonwealth partners now also contemplating recognition, particularly Australia and New Zealand.

Recognition can bring with it two rare commodities – hope and respect. Hope that there will be a genuine and sustained international effort, with the United Kingdom at last playing its full part, to address inequalities, discrimination and shared insecurity by exclusively peaceful means on the basis of international law and UN Security Council resolutions. Hope that Israelis can live in safety, recognised by all their Arab neighbours, and that the Palestinians can realise their right to self-determination.

As for respect – the United Kingdom has shown scant respect for Palestinian rights for a century and more. Recognition of Palestine alongside Israel would begin to show parity of esteem for two peoples, Palestinian and Israeli.

It is not the whole answer. But it's the right start.

• UPDATE: Scotland's first minister and SNP leader John Swinney has written to Prime Minister Rishi Sunak and Labour leader Keir Starmer to demand that they recognise a Palestinian state. Speaking on a campaign visit to an exhibition of poems written by children in Gaza (see article below), Swinney claimed his party had been Westminster's moral compass on the conflict in Gaza. He also said it is important the UK "take steps to bring about an immediate ceasefire". He added, "this catastrophe has got to be brought to an end. We have to stop selling arms to Israel."

Spain, Ireland and Norway have formally recognised a Palestinian state, in what they say is an attempt to refocus attention on efforts to find a political solution to the war in the Gaza.

BEAUTIFUL RESISTANCE: THEATRE FROM GAZA NOW – WEDNESDAY, 22 MAY 2024

An evening of powerful storytelling and moving theatre performances from Gaza, showcasing the beauty and resilience of the human spirit with an illustrated talk by Nick Bilbrough, the founder of the educational charity Hands Up Project sharing the stories behind two short plays. Through its network of volunteers HUP connects children around the world with young people in Palestine. By means of online interaction, drama and storytelling activities, it enables the use of creativity and self-expression to promote mutual understanding, personal growth, and the development of English language skills.

The first play: **It will be over soon** is performed by children in a newly formed drama club in Jabalia camp, northern Gaza. The second play: **I can 2024** is a remake of a winning play from the 2018 remote theatre competition, performed from their tents in Rafah.

Anne O'Connor writes: I watched Nick's moving presentation. The children clearly enjoyed putting together their short plays which they performed in English. This was partly to improve their language skills but also, as we learnt in the Q and A, to give a degree of distance from the situation they are in – by using a language other than their own they can develop a new persona that takes them out of the horrors of war.

Basim, one of the winners of the drama competition of 2018, reprised his play 'I Can' for 2024, performing with the same two friends, standing together among the rubble.

During the play he says: "we suffer but we are born again amidst the suffering. I can achieve anything." The image (right) shows him with the words "I am a human" written across his arms. In the final frame of the film we see Nick and then other adults and children holding up their hands, palms facing, with the words "we can" written clearly.



The film then pans out to give smaller and smaller images of all the hands in one great montage, accompanied by rousing music. This scene had echoes of the closing credits of Richard Curtis' hit movie Love Actually which gives a similar focus on the power of love and solidarity.

Basim says: "Yes, I can. I am a human. I always knew you were with us, holding our dreams, listening, sharing our pain, wanting to help. It's not 'I am' anymore. It's 'We can.'"

Nick's talk accompanies a touring exhibition **Moon Tell Me Truth**, with art and poems from the children of Gaza, at the Scottish Poetry Library from Thurs 28 May-Thurs 20 June 2024 free and open to all Mon-Thurs 10am-3pm. The event is supported by the Scottish Palestinian Forum and Peace & Justice (Scotland) as part of a series of events across Edinburgh curated by Heather Kiernan and Iliyana Nedkova to support the Hands Up Project.

UPDATE: May 20, Heather Kiernan writes: Children in a besieged enclave write poems inspired by two paintings. They enter them for a competition and the competition poems are made into a book, complete with the two paintings and illustrations by the poets for their poems. At least two of the children whose poems are in the book were killed while the others have been displaced. Meanwhile the poems, and the pictures, were made into an exhibition that is travelling to Edinburgh this week. At rallies and events supporting Palestine, and at openings of the exhibition, the poems are read out.

Fatema Saidam, killed last October aged nine, with her whole family, lies as dead as Homer and Sappho, and her words are working in the world just like theirs:

Legs are for walking slowly And also run Hands are for shaking with friends Not for shooting gun

May 21, Heather writes: Yesterday I posted the poem of young Fatema who, along with her family was killed last October by an Israeli airstrike. Today's poem is by 14-year-old Obada who also wrote his poem for the Hands Up poetry competition. He was killed last October in an Israeli airstrike. I was struck by the illustration that accompanies the poem. The words seem to emanate from a heart, almost medical in design. This is Obada's poem:

I always dream of a life Clear as the serenity of the sky. And a heart beating with love and optimism. Why our smiles don't bloom like the flowers?

Let us fly as freely as those butterflies ... Satisfied, colourful and flapping sky-high, Away from worries, anxieties and sorrow.

May 23, Heather writes:: Today's poem is by Roa'a Al-Masri, aged 13.

My darling's face is sad. The moon's face in our homeland is sad. Sad you are my city ... you the spring of tears and a long sad history ... you are the painting of pain and expressions of pain. Your eyes have the green colour of olives and the blue colour of sea ... while the night falls over the face of life. Darling: wipe out that sadness and weave the dress of impossible from the tears.

June 2023, Alice Oswald writes: 'Wipe out that sadness and weave the dress of impossible from the tears.'

"Those lines by a 13-year-old have stayed in my head since I read them and now I will always think of poetry as the dress of impossibility. How wonderful to make clothes out of tears and alter the world by wearing it. Even more wonderful to know that this poem, like the others in this book, was written by a student under fifteen, for whom English was a second language.

FRIENDS OF THE HOLY LAND

Caroline Ward writes: Friends of the Holy Land was established in 2009 and is an ecumenical, non-political charity. We work to support the lives and witness of Christians living in the Holy Land through prayer and practical projects, recognising that their presence in the land where Jesus once walked is an important witness to all Christians.

We fund a mixture of sustainable and immediate relief work and our beneficiaries come from all Christian communities in the Holy Land. A network of lay and clerical professionals, rooted within the Christian community in the Holy Land verify our projects and beneficiaries. They quickly identify cases where our support has the potential to make the Christian community stronger and more resilient.

Our mission is to secure a resilient and enduring Christian community in the West Bank, Gaza, Israel and Jordan. We achieve support for our mission in the UK in four main ways:

- Raising awareness: of the challenges faced by Christians in the Holy
- Prayer: we encourage prayer on their behalf
- Fund Raising: we generate funds to provide practical help
- Pilgrimage: we encourage visits to the Holy Land to meet local Christians

Our work focuses on five key areas:

- Education
- Employment
- Health
- Housing improvement
- Emergency Support

The war in Gaza has devastated the community. There were approx. 1000 Christians in Gaza at the start of October. Some have been lucky enough to leave but most are sheltering at the Holy Family Church (Latin parish) or St Porphyrios (Greek Orthodox). Many have no homes to return to.

The effects have been much wider reaching than just Gaza. The West Bank has been locked down. Borders have closed. Tourism has stopped. Estimates suggest over 200,000 people lost their jobs in the West Bank, about 24% of employment (International Labour Organization). But most of all there is fear. Fear of escalating violence, fear of being shot or attacked, fear of demonstrations and indiscriminate arrest and fear of an uncertain future.

The most important thing Friends of the Holy Land are doing during this time is being in contact with our team and continuing to fund our projects as well as looking to new projects. We cannot change the situation, but we can make it a bit more bearable by giving our support - practically, prayerfully and emotionally. We speak to our team and Committee in the Holy Land several times a week. We let them know that they are being remembered in prayer by Christians all over the world, as well as the financial support being offered.

The people of the West Bank are proud of their heritage and where they live; they don't like making their tragic circumstances public. They do not want sympathy from us, they do want practical help. Friends of the Holy Land has sent £120,000 of aid directly to the Christian communities in Gaza. We have increased emergency support in the West Bank. We are exploring more projects to support employment and healing of the most vulnerable, including psychosocial interventions for trauma support, scholarships for vocational training, water projects to replace rusty tanks and enable access to clean water and employment and empowerment opportunities for women and young people.

We want to help the Christian community to rebuild a sustainable future to remain in the Holy Land.

New Chairman to guide us through the challenging times ahead. Sadly, Jim Quinn has retired as both a Trustee and our Chairman in April. Jim had been a Trustee since 2013 and we are most grateful for his many years of guidance and dedicated service, helping Friends of the Holy Land grow to where it is today. We are very pleased to announce that the Rt Rev William Kenney has agreed to take over the role as our chairman, with immediate effect. An Auxiliary Bishop Emeritus of the Archdiocese of Birmingham, +William is well known for his work internationally, especially the Middle East, being involved for many years with the Holy See's Holy Land Coordination.

TOGETHER FOR THE COMMON GOOD: THE UPPER ROOM

When the day of Pentecost came, they were all together in one place. Acts 2 v1

Jenny Sinclair writes: A General Election is a time to consider seriously the condition of our country. One way to start might be to focus on policy, but this can miss what's really going on: the policy agenda is often driven by a political class disconnected from the country. Another way is to approach the question from the old political categories of left and right, but these can be misleading. And both approaches omit the transcendent. A better way for Christians is an approach anchored in God's reality. We might imagine doing this somewhere like an "upper room".

An upper room brings to mind a rarely used space at the top of a house, or even a practice of solitary prayer. But in first-century Holy Land the upper room was a place of communion. It was a place of fellowship and reunion, of encounter with scripture, of conversation and deliberation, a place to gather around a meal at the end of a long day. It's said that even the poorest families kept such a room furnished so that guests could be welcomed.

It was this kind of upper room where Christ met with his disciples. It was in such a room that he washed their feet and ate the final Passover meal. It was here our Lord introduced the communal practice of the Eucharist and here that the apostles received the Holy Spirit. It was in the upper room that they discussed their engagement with the world, and from here they left and here they returned. Perhaps our distinctive approach to consider the state of our country might be best done somewhere like an upper room.

Some of us are fortunate to have such a place of fellowship. But for many, spiritual life is a solitary activity. Like going to the gym, in the dominant individualistic sea in which we swim, even the idea of prayer is privatised. But the early church was communal: at the heart of the home, it was grounded in the neighbourhood and infused with the Spirit of God.

Our discernment around what is going on in our country needs to be anchored in a similar way. The framework of Catholic Social Teaching can help: sometimes referred to as the theology of the Holy Spirit in practice, it infuses our deliberations with both the transcendent and the rootedness of real life. Attuned to God's view, it trains us to join him in the neighbourhood, look for the flourishing of human beings, communities and relationships, and to call out any system which overcentralises power and undermines human agency.

Seeing our country through this portal reveals an operating system geared to benefit finance capital, generating human distress, failing to serve the interests of families and communities. A forty-year neoliberal misadventure, perpetuated by parties of both the left and the right, has driven a low wage, high welfare economy. This model has enriched a few while 5.2 million people are on out of work benefits and 14 million are classified as living in poverty. This ideological mismanagement has broken large parts of our country. And so we see the reason for the disconnect, and why people are so angry and alienated. A new government promising "stability" while not delivering fundamental reform is not serious about change, even if they use that language. The fundamentals will stay the same. There will be a continuity of collusion between government and big corporations to insulate financial interests from democracy. This is unacceptable from a Christian point of view.

A new government may well attempt mitigation by further centralising the welfare state, but the system inevitably will continue to generate pathologies that far exceed capacity. The churches will no doubt be invited to partner with social action and service-providing help. But the risks to the church are real: saviour complex, becoming a handmaid to the state, burnout and mission drift. Perhaps the greatest risk is that the church will inadvertently end up propping up an unjust system, alienating the very people it aims to help.

Instead of delivering services in a benefactor-recipient dynamic, Christians are called to build local relationships of reciprocity. The churches themselves are marginalised and in need of friendship: they must learn to receive as well as give. Together we can build a common good to resist the principalities and powers of the day. At a time when global instability is likely to get worse, emerging forms of local association are going to become more and more important. To ward off the darkness of this new time, we will need many upper rooms. We'll need places of communion, and to become communities of place.

THE BIG RIDE FOR PALESTINE: RIDE AGAINST GENOCIDE AND OCCUPATION IN 2024

Calling all cyclists and supporters from Merseyside, Wirral, Cheshire and North Wales, for this year's Big Ride for Palestine.

The Big Ride for Palestine started 9 years ago in response to the devastating loss of children's lives already happening in Gaza in 2015. Riding is a great way to show your solidarity for Palestinians and raise funds for Middle East Children's Alliance (MECA) for children's projects and more recently, for Palestine Riders and for the Gaza Sunbirds paracycling team.

2024 has been very different from previous years with the horrifying genocide in Gaza and the unending harassment of Palestinians in the West Bank. Sadly, we have also witnessed the brutal destruction of playgrounds like the one The Big Ride funded in Beit Lahia, northern Gaza.

Jane Marshall writes: This year The Big Ride is going Regional. I'm contacting you as a member of the organising group for our Region. The ride will be in Liverpool on Saturday 20 July and we are busy getting the route sorted and planning a really good day for cyclists and supporters.

At present it's looking to be about 26 miles through city parks, a cycle way, some quiet roads and some busy roads where we can make an impact. There are opportunities to do a shorter ride by hopping on a Merseyrail train partway. There'll be a rally at the beginning from 10am at the Pier Head and a fund-raising social event with food from about 5 in Liverpool 8 - we're working on this now.

We're very much hoping that there'll be riders from across the region, and also volunteers for marshalling on the ride, providing support vehicles, mechanical and first aid, help with rider registration, support at the break stops, support with the evening event, food, offers of accommodation for those from afar, and generally to help raise awareness of the ride and get riders.

DREAMING OF A HARMONIOUS EARTH

17 May 2024: Pastor and Climate Change activist Brian McLaren shares his vision of a restored Earth where humans live equitably with the Earth, other humans, and the more-than-human world:

This is my dream, and perhaps it is your dream, and our dream, together: that in this time of turbulence when worlds are falling apart, all of us with willing hearts can come together ... together with one another, poor and rich, whatever our race or gender, wherever we live, whatever our religion or education. I dream that some of us, maybe even enough of us, will come together not only in a circle of shared humanity, but in a sphere as big as the whole Earth, to rediscover ourselves as Earth's multi-coloured multi-cultured children, members of Team Earth.

I dream that the wisdom of Indigenous people, the wisdom of St. Francis and St. Clare and the Buddha and Jesus, the wisdom of climate scientists and ecologists and spiritual visionaries from all faiths could be welcomed into every heart. Then, we would look across this planet and see not economic resources, but our sacred relations ... brother dolphin and sister humpback whale, swimming in our majestic indigo oceans, with sister gull and brother frigate bird soaring above them beneath the blue sky. We would see all land as holy land, and walk reverently in the presence of sister meadow and brother forest, feeling our kinship with brother bald eagle and sister box turtle, sister song sparrow and brother swallowtail butterfly, all our relations.

In my dream, the reverence we feel when we enter the most beautiful cathedral we would feel equally among mountains in autumn, beside marshes in spring, surrounded by snow-covered prairies in winter, and along meandering streams in summer. In my dream, even in our cities, we would look up in wonder at the sky, and a marriage between science and spirit would allow us to marvel at the sacredness of sunlight, the wonder of wind, the refreshment of rain, the rhythm of seasons. At each meal, we would feel deep connection to the fields and orchards and rivers and farms where our food was grown, and we would feel deep connection to the farmers and farmworkers whose hands tended soil so we could eat this day with gratitude and joy.

In my dream, our life-giving connection to each other and to the living Earth would be fundamental, central, and sacred ... and everything else, from economies to governments to schools to religions ... would be renegotiated to flow from that fundamental connection. In my dream, we would know God not as separate from creation, but as the living light and holy energy we encounter in and through creation: embodied, incarnated, in the current and flow of past, present, and future, known most intimately in the energy of love.

NEW DOCUMENT: CALLED TO BE PEACEMAKERS

A Catholic approach to arms control and disarmament published by the Department of International Affairs of the Catholic Bishops' Conference of England and Wales.

The publication affirms that: 'As Christians, we are called by Jesus to be peacemakers (Matthew 5:9) In the modern world, an integral aspect of this mission involves working to limit the proliferation of weapons and advancing the cause of global disarmament' and that 'these challenges are relevant to the mission of the Catholic Church in England and Wales today'.

Pax Christi UK writes: We welcome the publication and are grateful for its clarity on a number of issues which are key to our work and campaigns. The Bishops are calling, for example, for the UK Government to fulfil its obligations under the nuclear Non-Proliferation Treaty, to sign and ratify the Treaty on the Prohibition of Nuclear Weapons and to promote an end to the UK's role in the global arms trade. They urge the Government to take meaningful steps towards General and Complete Disarmament and, in particular, to support a new UN Special Session on Disarmament. This is something we are currently involved in calling for with Scrap Weapons.

The Bishops ask us, with them, to support the diversion of military spending towards spending on peace and integral human development which will be one of the key calls we will be making in the upcoming General Election.

They promote the principles of 'Mensuram Bonam' in relation to investment in the arms industry which will be a support in all campaigns arguing for divestment by Catholic investors from any companies involved in the arms trade or the development and manufacture of nuclear weapons. In their concluding reflection, the Bishops remind us that Jesus marked out the path of nonviolence. We believe, of course, that it is along this path that we can find the fresh hope, energy and tools we need to eventually put an end to war. This truly is the 'radically counter-cultural approach' the Bishops refer to in their conclusion and we invite everyone to join us who wants to explore that approach further and work for its realisation.

Just Worship is a new book by Stef Benstead, which will explore questions of giving and justice, and challenge Christians to live lives that reflect the God they worship. The book will be published in July 2024 by Darton, Longman and Todd. We know the book will be a fascinating read for anyone interested in how we live out our faith and work for justice. We hope many supporters of Church Action on Poverty will read it.

The book's synopsis: God loves a cheerful giver. He must, then, hate an uncheerful giver. And he must loathe taxes. Right? Or perhaps not. And what about those on the receiving end of charity; what do they prefer? They might prefer justice to charity. Christians are called to be holy as God is holy, and perfect as God is perfect. The way we live should lead people to praise God, as our good deeds show the world what God is like. So what is God like? How do we live lives that reflect his character? How do we make sure that every part of our lives – not just the religious parts – are lived in worship to God? And in particular – how do we work for justice and live just lives as part of our worship of God? Just Worship explores all these questions.

About the author: Stef Benstead is an independent researcher in disability and welfare. Chronic illness means that her capacity for activity is limited, and she is dependent on social security for her main income. She is an evangelical Christian committed to working for justice for people in poverty in the UK. She is a trustee of Church Action on Poverty and a member of Manchester Poverty Truth Commission. She is currently studying for a Master's in Theology, Community Development and Social Change at the Nazarene Theological College. This will be Stef's second published book. Her first was *Second Class Citizens: The treatment of disabled people in austerity Britain.*
