ACTION OF THE WEEK

Is Modern Slavery a Big Problem?

The simple answer is "yes".

RENATE (Religious in Europe Networking Against Trafficking and Exploitation) held an Awareness-Raising Webinar this week, which covered it's mission, health and prevention, the power of stories and harnessing the power of social media and technology. It also showed how many Groups are working to tackle the issue. The recording of this Webinar is not on their website yet, but should be soon. In the meantime, our Action this week is to check out the RENATE website, and subscribe to their newsletter.

NEWS AND COMMENT

1. Modern Slavery and Human Trafficking

Modern slavery is a crime against humanity. That's legal speak for one of the worst crimes out there!

Victims can be any age, race or gender. Some don't even understand that they have been exploited or are entitled to help or support.

You can make a huge difference by knowing the signs of possible exploitation and how to report it. Details of how to spot exploitation can be

found on the <u>Medaille Trust website</u>. There are also real-life stories about the people that the Medaille Trust are helping, and how they came to be in the position that they did. <u>Read them here</u>.

Anti-Slavery International are also working to end slavery. Details of their work is available here.

They are running a campaign to Help Protect Victims of Slavery in the UK, many of whom are beaten, raped and enslaved - and then sent to Detention Centres. To add your name to the e-petition, click here.

2. Human Rights Day 10th December 2020

Human Rights Day is annually celebrated on 10 December. It marks the date when the United Nations General Assembly adopted, in 1948, the Universal Declaration of Human Rights (UDHR) – a milestone document that proclaims the inalienable rights of everyone regardless of color, race, religion, sex, property, birth, language or status.

For the annual observance this year, the UN proposed "Recover Better – Stand Up for Human Rights" as the theme. It relates to the ongoing Covid-19 health crisis, focusing on the importance of building back better by ensuring that Human Rights are at the centre of recovery efforts.

The Holy See's Permanent Observer to the United Nations, Archbishop Ivan Jurkovič reflects on the Church's role in promoting respect for the inalienable human rights of all in an interview with <u>Vatican News</u>.

On the flip side of this, in Pakistan, Christians and other religious minorities, as well as vulnerable and defenceless people, have been called to observe a "Black Day for Human Rights" across Pakistan on the same day in protest against the increasing number of violence and violations of their inalienable rights. 3. Latest NJPN Columns in The Universe

4th December: - Fr. Rob Esdaile (Parish Priest of Our Lady of Lourdes,

Thames Ditton) 'A Time for Eccentrics'

Advent is an eccentric time. I don't necessarily mean 'odd' (though the way our culture has stuffed a season of restraint, pregnant anticipation and hope with Yuletide feasting is definitely quite contrary). I mean it's focus lies beyond itself. It points both to the future (Christ will come again) and the past (his birth at Bethlehem) to provoke an encounter in the present. And, as with those mechanical systems which operate outside their natural centre of gravity, there is something inherently unsettling in that. A good living of this season draws us beyond habitual orbits.

John the Baptist is the Advent figure par excellence and undeniably eccentric in both senses of the word. Decidedly odd (all camel skins, locusts and wild honey) and a bit too 'shouty' for our tastes, he also points beyond the here and now. He is the voice crying in the wilderness, 'Prepare a way for the Lord!' (Mk 1.1-8) and 'the witness to speak for the light' (Jn 1.6-8).

A leader whose narrative was not about himself: that would be a refreshing prospect! A figure both indicating a way forward and inviting the whole community to unite in making straight the crooked paths: that is surely what

we need if we are to 'build back better' post-pandemic. But if we want that to happen in the political space, then we need prophetic voices in the Church space, too. We need to allow ourselves to be eccentric in the truest sense. Our focus also must be beyond ourselves, our centre of gravity outside our own immediate orbit, fixed on God's Kingdom and the sharing of God's mercy.

However, if we choose that trajectory we shall certainly be viewed by our neighbours as eccentric in the other sense. There is something odd about Christians who speak up and act up, not just observing the crooked ways but demanding change and working with the like-minded to achieve it. There is something peculiar in those who embrace sufficiency in a world of excess – contenting themselves with 'wild honey and locusts' rather than the overprovisioned online shop. Some understand that here and now truth is not yet fully realised and that our pilgrimage, our struggle, must go on. Yes, that is all a little strange – though not as strange as the prospect of Jesus Emmanuel, Divinity enfleshed in a new-born infant in a borrowed byre in Bethlehem. That truly is eccentric.

'Clothing and Justice'

This week two retail giants, Debenhams, with stores in 240 high streets, and Arcadia Group, owner of Top Shop, have gone into administration, putting tens of thousands of shop workers, mostly women, at risk of losing their jobs.

While many are opposed to fast fashion, others still dream of a new outfit for every night out, even though these days there is never a night out. Knowing this, fast fashion brand Pretty Little Things has been giving away cash prizes of up to £10,000 in order to lure back its customers. By its very

nature fast fashion depends on exploitation and wastefulness, with many clothes ending up in landfill.

I really enjoy clothes. I enjoy the sensation of different textures and colours. This lock down, I've found upcycling a rewarding pastime. Through mending and darning jeans in particular, I have learnt a lot about their construction. Supposedly workwear, they turn out to be not fit for purpose. The fabric is brittle and comes apart after just a few washes. The rivets and buttons make them unrecyclable. In contrast, a well-made cardigan can last as long as a building, unless it's attacked by moths.

In a time when I hardly step out of my pool sliders, clothes have acquired a new weightiness. Getting dressed to go out and meet a socially distanced friend, means taking care to be warm enough, and appear 'decent', as my grandmother would have said.

During Advent we're supposed to be getting ready. It is a custom, after all, in many cultures to buy new clothes for an important feast day. Clothing images feature strongly in an Isaiah reading from the Third Sunday of Advent. 'He has clothed me with a robe of salvation and wrapped me in a mantle of justice' [61:11].

In this image of bride and bride groom, adorned with ornaments and jewels, the garment in question represents perfect justice. Isaiah, a few chapters earlier, writes, 'Look, they are falling apart like a garment, the moth will eat them up' (50:9). Accusers with no case to answer are like a badly-made piece of clothing. This garment represents shame and emptiness.

Every fifty metres on my high street of boarded up shops there is someone hungry and begging. The council has forgotten the Christmas decorations.

The high street giants need to read the signs of the times. In a time of injustice and inequality, we know their garments will fall apart.

4. Climate/Environment Matters

Faith, Science and Youth Webinar - This took place on the 9th December, but if you missed it live, you can still catch up with it on YouTube.

It was organized by the Vatican Covid19 commission and its partners. In this webinar, you will hear from H.E. Cardinal Peter K.A. Turkson, Prof. John Schellnhuber and Hindou Oumarou Ibrahim; an exchange on calls and expectations towards the Climate Ambition Summit, which was held on the 12th of December on the occasion of the 5th anniversary of the Paris Agreement. The aim of this webinar is thus to urge governments to raise ambition through a faith, science, youth voice.

"We've won! The Prime Minister has announced that the UK will end public investment in new climate-wrecking oil and gas projects overseas. This is massive news. And you should be incredibly proud that you helped make it happen.

Throughout 2020, tens of thousands of you called on the government to stop the funding of fossil fuel projects abroad. And today (12th December 2020) – on a day that marks the 5-year anniversary of the signing of the historic Paris Agreement – your sustained pressure has paid off."

COP26 Coalition



The COP26 Coalition is a civil society coalition made of groups and individuals from a range of constituencies in Scotland and the rest of the UK, including trade unions, direct action networks, climate justice groups, environment and development NGOs, faith groups, students and youth, migrant and racial justice networks.

For those who don't know, COP26 is an international summit under the United Nations Framework Convention on Climate Change. The United Kingdom will host the meeting, originally planned to take place in Glasgow in November 2020. Due to the COVID-19 pandemic it has been postponed to November 2021.

5. Covid-19 and an action

It has not been a good week in regards to Covid-19 statistics in this country. Cases are very much on the increase, and we have all been asked to keep up with all of the measures that have been put in place. The good news is, for the UK at least, that the vaccinations have been started

(although many of us are concerned about the limited testing that has been done). Having said that, at least our Government has been able to afford the vaccine. Many will not be so lucky, as highlighted in the following news report from Oxfam on the 9th December.

Campaigners warn that 9 out of 10 people in poor countries are set to miss out on COVID-19 vaccine next year. Rich countries have hoarded enough doses to vaccinate their entire populations nearly three times over.

It goes onto say that nearly 70 poor countries will only be able to vaccinate one in ten people against COVID-19 next year unless urgent action is taken by governments and the pharmaceutical industry to make sure enough doses are produced. Read the full report here.

The Catholic Bishops Conference for England and Wales have issued a follow-up statement on the Covid-19 vaccinations, expressing that one may, in good conscience and for a grave reason receive the vaccine even if it has been developed from cell lines originating from an aborted foetus in 1983. 6. Refugees/Migrants

Can the UK Government decide to arbitrarily deny asylum claims?

The Truth about Refugees

Seeking Sanctuary have produced this <u>YouTube</u> video about the refugee situation, and the reasons why people feel driven to leave their own country.

'Seeking Sanctuary' aims to raise awareness about people displaced from their homes and to channel basic humanitarian assistance from Faith Communities and Community Organisations via partnerships with experienced aid workers. "Our special concern is for the 2000 or so exiles who are stuck in north-western France, mistakenly expecting a welcome in the UK.

They need food, water, good counsel and clothes, which are accepted, sorted and distributed by several organisations, including two Calais warehouses which also supply needs further afield."

7. Middle East

Christians Leaving the Middle East

On the 10th December, the Vatican organised a meeting of over 50 Catholic agencies to address the humanitarian emergency, the refugee crisis and the exodus of Christians from Syria, Iraq and neighbouring countries. Concern at Humanitarian Situation in Ethiopia

As fighting continues in some areas of northern Ethiopia, aid agencies are warning of a deteriorating humanitarian situation. Expressing his concern for defenceless citizens, Pope Francis has twice appealed to warring parties in the Horn of Africa nation to reject violence and find a peaceful resolution to disagreements. 8. The Legacy of the Maryknoll Sisters murdered in El Salvador

On December 2, 1980, four Catholic missionaries from the United States working in El Salvador were raped and murdered by five members of the El Salvador National Guard. They were Maryknoll Sisters Maura Clarke and Ita Ford, Ursuline Dorothy Kazel, and lay missionary Jean Donovan. All four of the women had been urged to come home by their families and friends, but despite the escalating situation over there, they chose to stay. This tale of their incredible determination to keep on with their work, which led to their murder, is told brilliantly by Margaret Swedish for America Magazine. She links it in with the crisis we have been through this year, and asks where our faith lies. Well worth a read.

9. Just 51 Days until Nuclear Weapons are Illegal

Christian CND writes, 'After years of campaigning, lobbying and praying, nuclear weapons will be banned under international law on Friday 22 January 2021. This is something we have all worked and prayed for, and a time to pause, celebrate and give thanks God.'

Christian CND is teaming up with friends in the Network of Christian Peace Organisations for a range of activities ahead of the day. Please go to their website for more information.
