The Annual NJPN Conference at Swanwick with its variety of workshops and stalls does just that. This year it was particularly good to see people again, chat informally and enjoy time together in a way is not really possible on zoom.

While I was there, Maggie McSherry introduced me to Sue Gubric. Many of you will know Maggie who has been the Lancaster Diocesan Faith and Justice Commission worker for many years and is retiring in August. Sue is her replacement. From our conversation the idea arose that Lancaster Diocese could join with us at Mouthpeace. Sue appreciated this as she admitted she is on a sharp learning curve in this new job. I look forward to receiving information, news and articles from Lancaster Diocese in the future. The deadline for the Winter issue is mid November.

WHAT TO DO WHEN I GO HOME?

Marian Thompson writes: It was good to be back at the NJPN Conference meeting face to face ...even if we were partly covered with masks while indoors. We are used to this now. As usual there was a good range of challenging speakers.

I was inspired by Bishop John Arnold's homily at the Saturday Vigil Mass which, reflecting on the feeding of the five thousand, urged us like the disciples to share all that we had received at the weekend to feed others, not just sit in a holy huddle by ourselves and enjoy it. To help us with this sharing on Sunday morning Andy Atkins who is now CEO of A Rocha UK made some suggestions leading up to COP 26. He reminded us that however COP 26 turns out the world doesn't stop – afterwards there is still much to do. All our action has its own value. If we don't take action ourselves we have no credibility talking to politicians. If we do take action ourselves this adds value to our advocacy.

Andy urged us all when we returned home to:

- 1. **JOIN A CHURCH GREENING SCHEME.** Over 5,000 churches are already registered with one of these which can be: Live Simply (run by CAFOD for the Catholic Church in England and Wales), Eco Church (run by A Rocha for churches in England and Wales) and Eco Congregation (Scotland and Ireland). They work together to provide practical support for churches to deal with climate change, nature, pollution and resources. Has your church registered? If not start a conversation about doing this. If it has registered already work towards one of the awards.
- 2. **DIVEST IN FOSSIL FUELS.** Encourage your Diocese, church or community to take this step...this came up in both talks and questions during the conference. See more details below on pages 8 & 9
- 3. **ARRANGE A CLIMATE SUNDAY SERVICE** sometime before COP 26 . Details to help on https://www.climatesunday.org/ClimateSunday . Please register your service so Climate Sunday can inform the government just before COP 26 how many churches care about this. More on page 4

Apart from the individual actions we may take as a result of the weekend, how good it would be if all those there did something about the 3 above when they got home.

HOW SERIOUS IS THE CLIMATE EMERGENCY?

VERY according to the scientists who produced the INTERGOVERNMENTAL PANEL ON CLIMATE CHANGE – THE 6TH ASSESSMENT REPORT (9 August 2021). Based on 14, 000 studies and the work of more than 200 scientists this is the clearest and most comprehensive account of the science of climate change. Dr Tamsin Edwards from King's College London, one of the main authors of the report, points out that climate science has improved significantly since the previous IPCC report in 2013. In that report, human influence on climate change was "clear" whereas in the new report it is "unequivocal."

The report addresses the most up-to-date physical understanding of the climate system and climate change, bringing together the latest advances in climate science, and combining multiple lines of evidence from paleoclimate, observations, process understanding, and global and regional climate simulations. https://www.ipcc.ch/report/ar6/wg1/

SEASON OF CREATION (CREATION TIME) SEPTEMBER 1 - OCTOBER 4



Each year the Christian family unites for this worldwide celebration of prayer and action to protect the earth, our common home. As followers of Christ from around the globe, we share a common role as caretakers of God's creation. This year, the theme for the season is *A home for all? Renewing the Oikos of God*.

In Genesis God set a dome over the Earth. The word "dome" is where we get words such as 'domicile' and 'domestic'. In other words, God puts us all — all people, all life — under the same domed roof. We are all in the house, the "oikos" of God. God gave humans the ministry to take care and cultivate this oikos of God. The Rev. Dr. Martin Luther Continued....

THE SEASON OF CREATION IN MACCLESFIELD

Keith Taylor writes: It's a fixture at St Alban's Macclesfield. For a number of years the J&P Group has proposed a programme of events and daily reflections to celebrate the Season of Creation. 2021 is no exception. In spite of Covid and social distancing, a full calendar of things to do and to consider has been published. It covers each day from September 1st – the World Day of Prayer for the Care of Creation - through to the Feast of St Francis on October 4th . On some days there are even two suggestions!

An advantage for coordinator Bernadette Bailey of having done it before is that some past favourites can be repeated. So this year again there's a family cycle ride and picnic on the Middlewood Way and a walk "to appreciate God's creation" in Teggs Nose Country Park. Popular local beauty spots make these natural candidates for repeat.

Also, from past Seasons, St Alban's can rely on its partnership with St Michael's, the parish church of Macclesfield; this year even Continued....

more. Through the whole 2021 Season St Michael's has an outdoor exhibition of personal stories revealing responses to the climate emergency and pointing the way to COP26. On Climate Change Sunday both churches' services will be focused on the environment. On another evening there will be a concert at St Michael's "Songs of the Prophets—A Requiem for the Climate."

On yet another day, St Michael's host walkers on their way to Glasgow on their Camino to COP26 and provide a chance for all to "Meet the Pilgrims."

COP26 Is highlighted in events organised by St Alban's: a Zoom Talk by campaigner Ellen Teague "COP26 - the Time is Now to Act on Climate Change" and an after- Mass signing of the CAFOD "Reclaim our Common Home" Petition to the Prime Minister. The signing takes place on the same day as a litter-picking group sallies forth from St Alban's under the guidance of a local scout troop.

On the last Sunday of the Season at St Alban's there will be a collection of food to go to local charities, Watermill House (hostel for young people) and Cre8.

PAX CHRISTI REPORT

Joan Sharples writes:



Recently Pax Christi commemorated the bombings of Hiroshima and Nagasaki and also, the life and witness of Blessed Franz Jaggerstatter. Recalling the past, prompts us to reflect on our present and ask what is ours to do.

'Heartbroken' is the word that Pax Christi International uses in its statement on Afghanistan. After asserting the importance of 'immediate attention to physical and human rights, protections for the most vulnerable; accountability for atrocities; and diplomatic efforts to engage the Taliban at every level', it goes on to urge for 'a deep reflection on the failure of war and the need to invest in effective tools for building just peace' **

This provides a poignant context for the forthcoming Arms Trade Fair due to take place at the ExCel Centre in London this September - a showcase for the latest in handguns, ammunition and warships. Pax Christi and Quaker Peace and Social Witness will be holding a silent vigil from 7.00-8.00pm on Monday 13th September at the ExCel Centre. If you are not able to join the Vigil, hold those present in prayer.

Pax Christi's Education Worker, Aisling Griffin, wrote a recent excellent blog piece which appeared in Independent Catholic News in which she makes the links between violence and climate change: 'As the climate changes, there is and will be more competition for resources. This competition for resources, such as water or land, can lead to conflict and militaristic responses. It can lead to migration, tensions within and between communities and leave people and regions facing instability and insecurity. Conflict also has an impact on the environment, polluting the local area and damaging infrastructure'. The article is worth reading in full. **

SEPTEMBER 21 INTERNATIONAL DAY OF PEACE

In 2021, as we heal from the COVID-19 pandemic, we are inspired to think creatively and collectively about how to help everyone recover better, how to build resilience, and how to transform our world into one that is more equal, more just, equitable, inclusive, sustainable, and healthier. The pandemic is known for hitting the underprivileged and marginalized groups the hardest. By April 2021, over 687 million COVID-19 vaccine doses have been administered globally, but over 100 countries have not received a single dose. People caught in conflict are especially vulnerable in terms of lack of access to healthcare. https://www.un.org/en/observances/international-day-peace

CAN WE STOP THE LIVERPOOL ARMS FAIR (11-13 OCTOBER 2021)?

The organisers of AOC Europe 2021 (previously Electronic Warfare Europe 2021) are expecting to host the arms fair in Liverpool. What they say: "Meet world-leading experts to discuss their understanding of the issues, technology and capabilities that underpin evolving electronic warfare abilities, both nationally and in collective defence. Alongside a technical conference programme, the event features an exhibition area for specialist suppliers to showcase their technologies, products and services." https://www.aoceurope.org/

Following a strong local campaign, the event had been moved from Liverpool in November 2020 to Seville in May 2021. The May event again did not take place following further strong campaigning and was relocated back to Liverpool, being intended to take place in October 2021 at the council-owned ACC Exhibition Centre in Liverpool. At the fair, arms merchants whose weapons have been used to target civilian populations around the world, are due to use Liverpool to market and sell their arms and military technology.

The Mayor of Liverpool Joanne Anderson and city councillors have signed a statement objecting. They say "the arms fair is at odds with the socialist and peaceful values" of the council and raises "ethical and moral questions" but they acknowledge they have no power to stop it.

ON SEPTEMBER 11th Liverpool Against the Arms Fair, a local coalition of campaigners opposing the Arms Fair, have called a demonstration against the fair and invite us to join the protest and demand the fair does not go ahead.

SYNODALITY - A NEW WAY OF BEING CHURCH

From website of The Catholic Church Bishop's Conference of England and Wales: A two-year 'synodal' process is taking place in the Catholic Church from October 2021 that culminates in the final Synod Gathering of Bishops in Rome in October 2023. The overall theme is "FOR A SYNODAL CHURCH: COMMUNION, PARTICIPATION, MISSION"

It's an invitation for us, as Catholics, to 'walk together' and every member of the Church has the right to speak, and the obligation to allow those charged with the work of discernment the freedom to do so. For the first time, the Synod Office in Rome has produced a comprehensive process which encompasses the stated aim of the Holy Father that the Church in today's world should have a vision of missionary communion orientated to evangelisation.

THE PROCESS begins in the Particular (or Local) Church and then moves to the level of the Bishops' Conference. From there, discernment takes place in the Regional Area – for England and Wales, it will be steered by the European Council of Bishops' Conferences (CCEE) – before moving to the Universal Church with the final Synod Gathering of Bishops in 2023, sub et cum Petro. TIMELINE

The Synod, which presents itself as a real "synodal time", will be opened by Pope Francis on 9-10 October 2021 and subsequently in the individual dioceses by the respective bishops, on 17 October. As highlighted above, the synodal journey will then be marked by three phases:

Diocesan Phase (Local) October 2021 – April 2022

During which each individual faithful can participate in the diocesan consultation. This phase will end locally with a pre-synodal assembly: the culminating moment of diocesan discernment.

National Phase

A period of discernment will begin for bishops gathered in an assembly (Episcopal Conference). They will listen to what the Spirit has inspired in the churches entrusted to them. A 'synthesis' will be drafted and in due course sent to the General Secretariat for the Synod of Bishops along with the contributions of each of the local churches (before April 2022).

Continental Phase

September 2022 – March 2023 which will have the task of discussing the text of the first Instrumentum Laboris. Synod of Bishops (Rome)

October 2023 Finally, the synodal journey will culminate with the celebration of the XVI Ordinary General Assembly of the Synod of Bishops on the theme "For a synodal Church: communion, participation and mission"

From Catholic Church Reform Int'l website: Pope Francis has opened the door as wide as he possibly can inviting the people to speak out while all but forcing the bishops to listen to their people. He given us a window of opportunity – but it is a narrow one (between October 2021 and April 2022). Once that window closes the chance for the people to have any influence will be over. Join with people around the world by signing this petition to ensure that we, the people, will be included in this all important synodal process. Shrewsbury J & P Commission members' memories:

Joan Sharples writes: Charlie was Chair of the J&P Commission in Shrewsbury Diocese when I first got involved in J&P and eventually became the Diocesan Coordinator. I remember him as always cheerful, able to dissipate tensions and restore an equilibrium. Working with him, it was clear that beneath this sunny exterior lay a very deep commitment to many issues of justice and peace and it was also evident that this sprung from his quiet, but strong faith. Charlie was always ready to make connections between issues and to 'dig deeper'

as the 'see, judge, act' methodology of Cardin and the Young Christian Workers prompts us to do. As Chair, in the late eighties during Bishop Gray's time, through sensitive dialogue, he enabled the J&P Commission and its work to become a valued part of the diocese, a relationship which was deepened under Bishop Noble. In 2000 Charlie handed over the role of Chair. Charlie also played an important role at national level, serving as Chair and Treasurer for the national network. We travelled to London on the train together many times and I learned a bit about how toothpaste gets into the tube. He spoke with pride of his children and enthusiastically recounted tales of helping with sheep.

I'm sorry that in latter years, we lost touch and that I didn't know of his wife, Bernie's death. She was a great support to Charlie with J&P work, running creches at conferences when required and trying to stop Charlie doing too much! He was a true practitioner of his faith.

Anne O'Connor writes: I joined the Shrewsbury Diocese Justice and Peace Commission in 1985, at that time under the Chairmanship of Canon Kevin Byrne, a great advocate of lay involvement. He quickly passed the role on to Charlie who was enthusiastic, well-informed, encouraging and always incredibly supportive. I edited the quarterly Shrewsbury Diocese J&P bulletin continued on next page

The Daily Pressure from 1985, later to become MouthPeace, a joint magazine with Liverpool Archdiocese in 1993. I would send the draft bulletin to Charlie for review each quarter but he rarely asked for any changes. I'd just managed to get it to the printers in January 1988 before the birth of our youngest child, Catherine. When I returned home from hospital there was a massive bouquet of flowers in the front porch – from Charlie! A typically thoughtful gesture. Charlie not only led the Commission, which met four times a year, comprising a dozen or so activists from across our sprawling diocese (including two Anglicans); he also helped establish the Core Group which met once a month in Joan's home or mine alternately. This consisted of Chair, Vice-Chair, Treasurer, Secretary, Editor and anyone else who wished to contribute. A great deal of work was covered at these monthly gatherings – planning events, deciding policy, responding to current crises, always enhanced by lively discussions. Charlie would often bring a bottle of his home-made wine for us to enjoy after the day-to-day business had been completed.

I have many fond memories of Bernie and Charlie. Bernie was a terrific support to Charlie and similarly committed to J&P. I remember running a creche with her at one of the bi-annual diocesan J&P conferences at Crewe where she was in her element with the young children.

My husband, Calvin, was a member of the Commission in those early days too and sat on several interview panels with Charlie for the appointment of diocesan J&P fieldworkers over the years. Family was important to Charlie. He was very proud of his children and spoke of them often. It was interesting to read in the family's eulogy that Charlie was a convert. I believe this gave Charlie a special love for the Church and fostered his keen appreciation of Catholic Social Teaching. He lived the gospel in so many ways — his love for all, but especially for the poor and those on the margins, his kindness and humility, his strong sense of right and wrong. It was a privilege to know him and count him as a friend.



WHAT ARE CORPORATE COURTS?

More properly known as Investor State Dispute Settlement (ISDS) they are NOT courts as we think of them with a judge and jury applying laws passed by elected lawmakers such as MPs or MEPs. They are a means for a transnational corporation to sue a government for actions they do not like such as banning toxic chemicals, introducing a sugary drinks tax, anti-smoking policies, capping water rates. They sue on the basis that the government has enacted laws that are outside a trade agreement.

At the ISDS there are 3 ARBITRATORS who are international corporate lawyers - one chosen by the company bringing the case, the second by the government being challenged and the third by the previous two. Who are these arbitrators?

They are private individuals drawn from the top 20 corporate law firms in the world e.g. Freshfields in the UK. They are nearly all white men with a shared corporate aim i.e. to maximise corporations profits with no concern with issues relating to people e.g. human rights, workers' rights or the environment.

The arbitration takes place behind closed doors – no-one else has the right to know what evidence is given or who gives it. There is no right of appeal. Though corporations can sue governments through the ISDS mechanism, WE, the private citizens, HAVE NO RIGHTS TO SUE CORPORATIONS.

BLOCKING CLIMATE ACTION

Now that we are finally seeing more governments around the world begin to take long needed action to tackle the climate crisis, we are seeing more and more corporate court cases challenging those actions. They are an obstacle to clean energy transition and to achieving climate justice. For instance :

The Netherlands is being sued by two fossil fuel companies, RWE and Uniper, for phasing out coal power

The US is being sued by a Canadian fossil fuel company. TC Energy, after President Riden cancelled the Keystone

The US is being sued by a Canadian fossil fuel company, TC Energy, after President Biden cancelled the Keystone tar sands pipeline

One UK fossil fuel company, Ascent Resources, is suing Slovenia over fracking

A CALL TO DIVEST IN FOSSIL FUELS

"Some Dioceses have not committed to divestment in fossil fuels so they can make a bigger impact by participating in share holder action. What do the panel think is the most appropriate way to demonstrate the church's commitment to our common home and to win hearts and minds?"

This question at the NJPN conference to the panel on Saturday evening prompted a heartfelt response from Lorna Hill. Asking herself the question 'Can you hope to change policies of fossil fuel companies by action at shareholder meeting?" She answered firmly 'No'. Lorna gave several reasons for churches and other groups to divest from fossil fuels:

The Moral Case

She suggested that the fossil fuel companies are the single sector most damaging to our common home. They seem to be incapable of changing and openly say they will breach the Paris 2015 target of 1.5° temperature rise. If they were companies which were serious about change and meeting the Paris agreement then share holder engagement would maybe be useful. But she called them bad actors who have for decades sold misinformation and lobbied governments to delay – justice delayed is justice denied. Justice is denied to the poorer people already suffering and also to future generations.

The Financial Case

While fossil fuel companies have historically been very profitable, they are an increasingly risky investment. Since their business models are based on emitting five times more carbon than can safely be burned, they run the risk of being left with 'stranded assets' – worthless fuel stocks that regulation will prevent from being burned or that can only be consumed at unimaginable cost to us all. https://operationnoah.org/what-we-do/bright-now-our-divestment-campaign/



The announcement, which will take place on October 25th shortly before COP26, offers churches and other faith organisations an opportunity to emphasise the urgent moral imperative to divest from fossil fuels, given their destructive impacts on climate, biodiversity and human rights. Operation Noah, Laudato Si' Movement, Green Anglicans, the World Council of Churches and Green Faith invite your church or religious order to join the next global divestment announcement this October. In January 2020 the Dioceses of Middlesbrough and of Lancaster announced their commitment to divest from fossil fuels, becoming the first Catholic dioceses in England and Wales to do so. They have been followed since by the Catholic Dioceses of Arundel & Brighton and Hallam. In 2021, many UK Churches have taken the important step of fully divesting from fossil fuels, including the Methodist Church, the Baptist Union, Church in Wales and the Church of Scotland also the Church of England Dioceses of Oxford, Bristol and Sodor & Man. By participating in the global divestment announcement, your Diocese or church could send an important message that it is time to stop investing in fossil fuels, given their destructive impacts on climate, biodiversity and human rights.

Many churches (and Dioceses) hold investments in funds that have already dropped fossil fuel investments for financial reasons. These churches can make a commitment not to invest in fossil fuel companies in the future and send a powerful message calling for the national Church to divest too.

Churches and other faith organisations interested in joining the announcement will confirm (i) that they have divested from fossil fuel investments; or (ii) that they will divest from any investments in fossil fuels as soon as possible, and within five years at the latest; or (iii) that they do not hold any fossil fuel investments and will not invest in fossil fuels in the future. A WORLD WITHOUT NUCLEAR WEAPONS

TREATY ON THE PROHIBITION OF NUCLEAR WEAPONS

The United Nations Treaty on the Prohibition of Nuclear Weapons (TPNW) came into force on 22 January 2021. This new multilateral treaty makes it illegal under international law to develop, test, produce, manufacture, acquire, possess, stockpile, transfer, use or threaten to use nuclear weapons ... or to assist or encourage anyone to engage in these activities. However, the UK government refused to participate in any discussions and even issued a statement attacking it.

It continues to be open for signatory and ratification. 86 states have already signed, 55 have ratified. (After approval has been granted under a state's own procedures, it consents to be bound by the treaty. This is called ratification, and the treaty is now officially binding on the state).

Christian CND is urging the government to join this multilateral agreement. So far, the government has discouraged any support for it. Have you signed the petition ? https://christiancnd.org.uk/tpnwpetition/

Ask your Faith and Community groups, and Councillors to sign pledges of support. Many towns and cities around the world - including Washington, Paris and Manchester - are bypassing their governments' opposition and are becoming Nuclear Ban Communities, passing resolutions to support the TPNW. Background facts (provided by Stockport for Peace on their stalls in Stockport and Marple precincts on Hiroshima day)

The Nuclear non-Proliferation Treaty (NPT) opened for signature in 1968 and entered into force in 1970. The NPT objective is to prevent the spread of nuclear weapons and weapons' technology, to promote cooperation in the peaceful uses of nuclear energy and to further the goal of achieving nuclear disarmament and general and complete disarmament. The Treaty represents the only binding commitment in a multilateral treaty to the goal of disarmament by the nuclear-weapon states. On 11 May 1995, the Treaty was extended indefinitely. A total of 191 States have joined the Treaty, including the five nuclear-weapon States. More countries have ratified the NPT than any other arms limitation and disarmament agreement, a testament to the Treaty's significance.



The five states that had already acquired nuclear weapons before the treaty was signed are the UK, USA, Russia, China and France. The treaty establishes that those states without nuclear weapons agree not to acquire them and those with nuclear weapons agree to disarm. It also gives states the right to develop civil nuclear power. The UK does not have any right to possess nuclear weapons under the treaty; instead it is legally bound to disarm.

However the UK government recently announced that it is both upgrading and increasing our nuclear weapons, a provocative action, illegal under the treaty. See petition: https://cnduk.org/report-the-uk-to-the-un/

The tenth Review Conference is due to be held no later than February 2022.

The First Atomic Bomb was dropped by the USA on Hiroshima (6 August 1945) killing around 75,000 people immediately; and a second was dropped on Nagasaki (9 August 1945). Many have since died due to radiation.

Trident is Britain's nuclear weapons system made up of 4 nuclear submarines each carrying up to 8 missiles, each with possibly 5 nuclear warheads. A single warhead is over 6 times as powerful as the bomb which destroyed Hiroshima. A Trident submarine patrols the seas at all times. Replacing Trident is estimated to cost at least £205 billion.

Nine countries have nuclear weapons: China, France, India, Israel, North Korea, Pakistan, Russia, United Kingdom, and United States of America. Most pledge 'No First Use', though only China has an unconditional 'NFU' policy. South Africa is the single country to have built, and then relinquished its nuclear weapons.

Weapons of Mass Destruction have the potential to produce 'an enormous destructive effect capable to kill millions of civilians, jeopardise the natural environment, (with) ... catastrophic (future) ... effects'. These are atomic explosive, radioactive material, lethal chemical and biological, and any future similar weapons. See https://unrcpd.org/wmd/

The Chemical Weapons Convention (CWC) came into force on 29 April 1997. Currently, 189 nations, representing about 98% of the global population, have joined the CWC.

The Biological Weapons Convention took effect on March 26, 1975 and has now been signed by 183 states

Stop press: August 2012 Refugees who flew from Afghanistan to Birmingham are at present being housed in two hotels near Manchester Airport. Care4Calais Manchester volunteers were ready to welcome them as they arrived. Maddy Summerfield, Care4Calais Manchester coordinator said: "They're going to be in the hotel system for a while, it often takes a good few months for their asylum claim to get anywhere. We know they will be staying in hotels around the airport but we don't know where they will be dispersed to yet." "They will

have to isolate for 10 days and then we'll be allowed to operate. But this buys us some time to find out what's going on."

The Walk is continuing until 3 November 2021, through Greece, Italy, France, Switzerland, Belgium and Germany before reaching England and coming through the Peak District to its finale in Manchester. In each village, town or city she visits Little Amal will be welcomed by major new arts commissions, city-wide community performances and intimate events. All events are free and have been designed by The Walk, in collaboration with each local partner to create one of the most adventurous public artworks ever attempted. Audiences will be able to follow Little Amal's journey online and across social media, as well as joining in with events in their local area.



Little Amal represents the millions of displaced refugee children separated from their families. Her urgent message to the world is "Don't forget about us". Produced by Stephen Daldry, David Lan, Tracey Seaward and Naomi Webb for Good Chance Theatre, the producers of The Jungle, in association with the Handspring Puppet Company, the creators of the War Horse puppets, and led by Artistic Director Amir Nizar Zuabi. It takes three puppeteers to operate Little Amal; a stilt walker who also brings her face to life and one on each of her arms. 




Little Brother An odyssey to Europe by Ibrahima Balde, Amets Arzallus Antia and Timberlake Wertenbaker (Translatior)

STATE OF THE NATION 2021 - social mobility and the pandemic The Social Mobility's Commission's Report July.

It warns that the effect of the pandemic will be profound on a country where nearly one in three children live in poverty. Although its powers are limited to monitoring and promoting social mobility, the commission has put forward a series of seven recommendations to take 'bold and decisive' action and says 'now is not the time to cut public spending'.

- Seven key pillars for recovery:
- Geography and local power A levelling up agenda that promotes equal outcomes for people living in under-invested places, and not just strategies that improve places generally.
- Poverty and living standards The UK Government should make benefits more generous and account for different sized households in its calculations, starting by reducing child poverty by about a third.
- Early years Higher pay and a better career structure for a workforce crucial to social mobility. Expansion of the 30 hours childcare offer regardless of education or training status.
- Education A bigger focus on long-term deprivation, funding targeting, post qualification access to university and a student premium for those aged 16 to 19.
- Apprenticeships and adult skills Increase the share of apprenticeships from disadvantaged backgrounds and make sure more get on to the higher levels.
- Digital access Access to affordable broadband and digital devices for all households, as well as the skills to thrive in a 21st century world.
- Work and career progression Ensure that all employers measure the social diversity of their workforce and focus on career progression for those from lower socio-economic background, including those in low paid jobs.

The report was welcomed by the IPPR (Institute for Public Policy Research) North think -tank. "It recognises that the government's approach to levelling up needs to be as much about investing in people as it is about investing in infra structure" says Erica Roscoe, senior research fellow.

THE CLIMATE CRISIS IS A CHILDS RIGHTS CRISIS Report from UNICEF July 2021

The Climate change is the greatest threat facing the world's children and young people. We have known this for some time – based on what science told us, what the stories we heard from around the world have illustrated, and what we have witnessed with our own eyes – but today, we have the first analysis of climate risk from the most important perspective on this crisis – ours. UNICEF's Children's Climate Risk Index reveals that 1 billion children are at 'extremely high risk' of the impacts of climate change. That is nearly half of all children. And it is happening today.

The Children's Climate Risk Index (CCRI) uses data to generate new global evidence on how many children are currently exposed to climate and environmental hazards, shocks and stresses. A composite index, the CCRI brings together geographical data by analyzing 1.) exposure to climate and environmental hazards, shocks and stresses; and 2.) child vulnerability. The CCRI helps to understand and measure the likelihood of climate and environmental shocks or stresses leading to the erosion of development progress, the deepening of deprivation and/or humanitarian situations affecting children or vulnerable households and groups. https://www.unicef.org/reports/climate-crisis-child-rights-crisis



OPEN? THE UK'S SECRET ARMS SALES report by Campaign Against Arms Trade (CAAT) July.2021 The UK has sold over £20 billion worth of military equipment and services to Saudi Arabia since 2015, according to this new report. This is almost three times higher than the £6.7 billion worth of arms sales published by the Department of International Trade in the same time period. The report exposes the real extent of UK arms sales to Saudi Arabia. The majority of sales have taken place using the opaque Open

Licence system that obscures true value.

TO VISIT: CLOUD STUDIES an exhibition by Forensic Architecture at the Whitworth Art Gallery Manchester until October 17th. Tear gas clouds spread poison where we gather, bomb clouds vaporise buildings, chemical weapons suffocate entire neighbourhoods and air pollution targets the marginalised. Our air is weaponised. Our clouds are toxic.

Cloud Studies includes the first phase of a major new Forensic Architecture investigation, commissioned for the Manchester International Festival by the Whitworth and MIF. The display includes a range of their investigations from Palestine, Beirut, Grenfell, Indonesia and the US-Mexico Border. It showcases the first phase of their major new work on ecological racism in Louisiana's so-called 'Cancer Alley', asking 'if toxic air is a monument to slavery, how do we take it down?'

These 'cloud studies' examine how the air we breathe is weaponised by states and corporations to suppress protest, maintain border regimes and perpetuate racism and inequality. It's not often you see a real paradigm-shift in the art world, but over the last decade Forensic Architecture have remodelled and redefined art's capacity to contribute to political discourse and effect meaningful change.

The Whitworth has co-curated with precision and care, exhibiting paintings from their own collection in A Useful Pursuit of Shadows, an historical and contextual response to Cloud Studies which reminds viewers of the long, local history of industrial pollution and toxic air in the North of England.

If you can't get to the Whitworth you can get an idea of the exhibition and hear a discussion between Alistair Hudson, Whitworth Gallery director and member Forensic Architecture
