

# CHURCHES TOGETHER IN LANCASHIRE: Social Justice / Social Responsibility theme - Warm welcome

Interest in offering 'warm spaces' as a response to the cost-of-living crisis is increasing. In the past few days, more and more locations have signed up with the Warm Welcome Campaign. <u>https://www.warmwelcome.uk/</u>

The campaign was started by the Church Works Commission working with key partners to support and champion the community response to the cost-of-living crisis. Already over 3,000 organisations have registered their premises, generating an easy-to-navigate map of locations. Churches Together in Lancashire is encouraging all churches who provide any sort of public provision to register their details at the warmwelcome.uk site – it's a very simple process.

The site has a list of resources that might be useful, such as food safety guidance and working with volunteers. Some denominations (Methodist, URC) are offering small grants to locations who register. If developing some provision is new for your





church, there was an excellent webinar on Warm Spaces run by colleagues from the Methodist church earlier this month which can be viewed at <a href="https://youtu.be/UnP3ZDCezuQ">https://youtu.be/UnP3ZDCezuQ</a>. Based on experience, this provides a lot of really good ideas and information that you need to think about when considering getting involved.

Another long-standing scheme is called Places of Welcome, a network of local community groups, especially churches, providing places where all people feel safe to connect, belong and contribute. <u>https://www.placesofwelcome.org.uk/</u>



Interest in PoW has also increased recently, and there are now over 500 locations registered. There is no reason why you should not register with both WarmWelcome AND Places of Welcome. With the latter there is direct support available from a local Near Neighbours co-ordinator, who can help you with issues relating to safeguarding, volunteer recruitment, publicity and fund raising.

Churches Together in Lancashire is also asking anyone registered with warmwelcome.uk or with Places of Welcome to host a Lancashire Sings Christmas (LSC) event, with the offer of a simple warm meal (soup/stew/hotpot) and of course hot mince pies and maybe even warm mulled wine!! This takes place on **Thursday 15th December**, **7pm**, live from the **studio of Radio Lancashire**. 



# **CAFOD NEWS**



*Marian Thompson writes:* On the week I was putting Mouthpeace together CAFOD held two informative webinars and I was able to join both. Here are some my impressions but I would encourage you to try and view them in full as they give a good impression of how wide reaching CAFOD's work actually is.

# LOOKING BACK ON CHALLENGES AND JOYS OF 2022

Webinar Host: Eileen Hayes, Volunteer Co-ordinator Specialist at CAFOD

With a short film we were reminded of the past year from CAFOD's perspective. Some joys: in January 1 billion doses of global corvid vaccine were shared. Later in May a Mass in Rome marked the first stage (the local phase) of the synodality process in the Church.

And the challenges: in February Russia invaded Ukraine which led to a rise in global food prices. For many this led to a food crisis with people depending on the distribution of emergency food and water which is not a sustainable option. Disasters and

emergencies followed around the world – in June a devastating earthquake in Afghanistan, in July many countries (even the UK) experienced record high temperatures, in August violence broke out in Sri Lanka and Pakistan experienced disastrous floods. In areas of Africa there were droughts as the rainy season failed again.

When Rhea Tariq, CAFOD Director of International Programmes was asked if she thought the number of emergencies was increasing she replied very positively 'Yes'. She explained that some people were caught up in one disaster after another, for instance heatwaves led to cyclones and devastating floods. Working with partners, CAFOD tried to help people to prepare for possible emergencies such as by building cyclone shelters or devising early warning systems for floods. This could be as simple as providing bikes and megaphones for people to provide a warning in areas with no other communication systems. As the disaster unfolds a very rapid response is important. Often stakeholders flee as quickly as they can but the church remains and offers immediate help on the ground. Later a different kind of help is needed in rebuilding physically but also emotionally.

Jenny Hayward-Jones, CAFOD Fundraising Volunteer Programme Coordinator, gave a presentation about the synodality project and its importance in giving a voice to the marginalised and to women.

Perlagia Kapuya, CAFOD Food Systems Specialist in Africa, had attended COP 27 but had technical difficulties in joining the webinar, just phoning in briefly towards the end to tell about her work with food systems. Perlagia has made a video and you can see her on the following CAFOD webinar.

Christine Allen, CAFOD Director, talked about COP27 from a CAFOD point of view. She explained it was important hear the voices of the people directly affected now by climate change and the establishment of the Loss and Damage Fund was a significant step forward for them. This was not something that had come out of the blue but was something people had been working on and pressing for over many years. There is a strong sense that the money for the fund should come from the polluters- fossil fuel companies and rich governments like ours. Like many of us, Christine was disappointed that there was no improvement on Glasgow in ratcheting up the 1.5° global warming target.

Finally Christine outlined CAFOD's priorities for 2023.

i. Building on their work on food systems. This is the lense through which CAFOD is looking at their climate work as food security is a real day to day experience for people.

ii. Lobbying and influencing the UK government about International Development (ID) spending and priorities. In these challenging times at home it is important that there is still a strong commitment and support for ID. Should this already reduced budget be used for the government's work with refugees and asylum seekers?

# WHAT HAPPENED AT THE COP 27 CLIMATE TALKS?

Education, CAFOD. Neil was also an official Vatican delegate at this COP27 as the Vatican now has a seat at the table having signed the Paris agreement in October of this year. There were 6 delegates from the Vatican and it was the second smallest delegation – the smallest was San Marino.

Diego : Food and agriculture is a newcomer to COP discussions yet  $\frac{1}{3}$  of greenhouse gases comes from agriculture. Discussions have been going on since 2017 and a report of these discussions was presented. It was agreed by the parties to work further on agriculture and food security over the next 4 years so it is now at last very much on the agenda.

He also described the layout of COP with its pavilions making it more like a fair. The size was difficult for smaller groups, those from the global south for example, to navigate which raised questions about justice, equality and fairness.

Neil: Agreeing to a Loss and Damage Fund is an historic agreement, 30 years in the making. But important issues have now to be worked out- who will govern it? who will pay? A transitional committee had been established to work on this for the next COP. Climate finance was not really looked at and Neil explained why.

Another important topic that came up for discussion was Food Systems and Agriculture. The Egyptian Presidency was particularly interested in this and pressed for it to come to this COP.

Perlagia Kapuya, CAFOD - Food Systems Specialist in Africa, had made a video describing her work. As well as involving food systems, she works on agriculture and land use, loss and damage, resilience, climate finance and gender justice. She emphasised that these could not be split into topics as all were interlinked and had to be considered together.

The webinar concluded with answering the questions in the chat.

# A PROPHETIC ROLE FOR THE CHURCHES

On 22 November Bright Now with Operation Noah launched their latest report: 'Church Investment in Climate Solutions: Financing a Liveable Future.' Read it here <u>https://brightnow.org.uk/resource/church-investment-climate-solutions-financing-liveable-future/</u>

The United Nations and International Energy Agency have highlighted the urgent need for investment in clean energy, stating that private and public investment in renewable energy must triple to \$4 trillion a year by 2030 if we are to reach net zero by 2050 and have any chance of limiting global heating to 1.5°C. If the world were to redirect the \$570 billion of annual planned oil and gas investments towards renewables, this could fully finance wind and solar energy expansion in line with the 1.5°C target of the Paris Agreement.

In order to ensure a fair and fast transition to clean energy and ensure a liveable future, especially for people living in poverty, investment in climate solutions needs to scale up rapidly – and Churches have a key, prophetic part to play calling on governments to implement policy that addresses the climate crisis at the speed and scale required.

Many UK Churches have now made commitments to divest from fossil fuel companies. As well as divesting from fossil fuel producers, it is vital for Churches to increase investment in climate solutions such as renewable energy and energy efficiency, which reduce the demand for fossil fuels.

James Buchanan (Bright Now Campaign Director at Operation Noah) and Julia Corcoran (Bright Now Campaign Manager at Operation Noah), who together co-authored our report and will present the key findings.

Lorna Gold is well known in J &P circles and was one of the main speakers at our Swanwick conference in 2021 on the theme 'Life on earth- a moment of truth'. Since then we have had COP26 in Glasgow and recently COP 27 in Sharm El-Sheikh. Lorna who has attended COPs in the past gave her verdict on the latest in Egypt..... 'a failure'. She conceded that the agreement to form a loss and damage fund was positive BUT the fund on its own is useless while the world continues on its present path to disastrous collapse. The economic model has not shifted and governments are still not committed to putting into action the rapid transition required. To Lorna it is unthinkable to people of faith at this stage in the climate crisis that our faith institutions are still investing in climate disaster. There are various mechanisms mostly voluntary to support transition to a low carbon future but the way the investment world is structured makes it almost impossible to know how investments are being made and the impact they are having. That is why so many faith institutions have adopted primarily a negative screening approach -the divestment in fossil fuels approach as a means of tackling the climate disaster. At least when you divest you are applying the ethical principle of 'Do no harm'. That is obviously a start. At Swanwick Lorna had been a keen supporter of faith communities divesting from fossil fuels and encouraged us to write to our Bishops about this. Now she is suggesting that divestment is selling the faith short because faith with its rich traditions and deep understanding of the nature of money can do so much more to support the emergence of a new economy. In fact Lorna suggests it is our moral duty to do so. If the webinar had been held ten years ago, she suggests, it would be difficult to point to solutions and their investability. But this is no longer the case . There are clear choices - good choices that point to what is sustainable, regenerative, circular and will shape the decade to come. It is essential that faith institutions with their control of trillions of dollars of assets worldwide should intensify their efforts to deliberately support the emergence of a low carbon, just transition. These investments can take many forms as the report suggests. FaithInvest\* the organisation Lorna works for gives help with this. They work closely with individual asset owners relooking at how their investment policies help to deliver the big vision of a just and sustainable world – or as we call it in the Christian world -the kingdom of God. Now is the time to put the kingdom back in the centre of our investment decisions in bold and prophetic way. It is eminently doable but we must be mindful that our investments are not just for today or tomorrow but for eternity. \*Find out more <u>https://www.faithinvest</u>

# Paul Southgate, NJPN Chair writes: Introduction to NJPN statement on 'Truth and Integrity'.

Thomas Aquinas said that "the proper objects of the heart are truth and justice." There is no justice without truth. Truth and integrity are of crucial importance to democracy, the rule of law and in relation to climate change. Tackling these issues is going to require truthfulness and much closer co-operation. Ultimately what is needed is a spiritual response based around Truth. NJPN has been particularly exercised over the last few months and years about truth and integrity in public life, or the lack of it. We are not the only ones. In March 2022 the Quakers launched a new group called the Quaker Truth and Integrity Group (QTIG) and they reached out to NJPN with an invitation to join their discussions. NJPN was delighted to accept and we invited QTIG to speak at our

Networking Day held on Saturday 12th November. After discussions, the meeting and the NJPN Executive endorsed the attached statement which we commend to our Network members.

## **Meeting statement**

Members of the National Justice and Peace Network and the newly formed Quaker Truth & Integrity Group met today at Romero House in London to discuss the subject of "Towards a Better Kind of Politics".

We have come away greatly encouraged by our meeting, at which we have been able to share deeply our concern about the state of truth and integrity in public life. We have discovered that we have much in common with regard to human values and human dignity. We from the NJPN warmly welcome and endorse the Declaration published recently by QTIG.

We are aware of the strength of unity and undertake to cooperate closely on an issue we regard as an existential one, which we are approaching from a common spiritual place. We are particularly aware of the importance of these issues to younger people, among whom there is a mounting sense of deep anxiety.

NJPN hopes to look at the issue of truth and integrity at its annual conference on the theme of sustainability in July next year and to invite ecumenical parties such as QTIG to join them. QTIG will in turn remain in close touch with NJPN as it explores the scope for ecumenical and interfaith cooperation.

## A BETTER KIND OF POLITICS Report of talks at NJPN meeting 12 November 2022

## The network heard from two speakers from the Quaker Truth & Integrity Group (QTIG) <u>www.quakertruth.org</u>.

Peter Hussey commenced his remarks by referring to Pope Francis' call for a better kind of politics - "one truly at the service of the common good". But is this a description that we would recognise of our current politics - do equality, fairness and the wellbeing of our neighbours feature in the interactions we see in our parliament, on our television screens, or in our news or social media? Or, instead, do we hear people who have stopped engaging and say : "There's no point - they're all the same". Democracy can only really exist when political leaders are honest and practise integrity. 'Spin' can be just a variation of emphasis but it becomes unacceptable when it is a lie. After 13 years in government, accusations of dishonesty and failings of integrity are bound to be directed primarily at the party in power but reminding ourselves of claims about the existence of "weapons of mass destruction" suggests that power, not political opinion, is the main enemy of truth. In light of these problems, the Quaker Truth and Integrity Group wants to work along with other groups to highlight injustice or failures in standards. Parliament itself has set out seven principles of public life (selflessness, integrity, objectivity, accountability, openness, honesty, leadership) see https://www.gov.uk/government/publications/the-7-principles-of-public-life and government needs to be measured against these principles. Whilst it is true that some may enter politics to line their own nests, many more, possibly the majority, want to improve the lives of the communities they represent. They are people who try to operate with honesty and integrity. QTIG are committed to finding such people and supporting them as much as possible by giving them positive reinforcement. QTIG seeks the "Kinder Ground" to offer to politicians, writers and administrators, away from the chill winds of recrimination and accusations - wanting to encourage those who stand for truth and integrity rather than, primarily, looking for fault.

Citing the example of the Brexit Bus with its promise of an additional £350m a week to spend on the NHS, Peter said that Boris Johnson might have to carry some of the blame for many of the lies and misconceptions around the Brexit referendum, but he

was only effective thanks to an army of other opinion formers. And this is part of the established pattern of misleading statements from our political leaders, whether it be "There is no alternative" to austerity, or the existence of "weapons of mass destruction". We see similar problems now in the discussion of climate change, or budgeting for capital projects. Our politicians and the media of the day provide a revolving door for a tiny group of people who manage information and opinion. Many work in parliament, but many others work in lobbying firms, think tanks and the media. The internet offers great benefits (fact checking etc) but also allows for lies, conspiracy theories and group thinking. A politics "truly at the service of the common good" is a precious thing that will take patience and kindness, as well as truth and integrity. It may require moving away from tribalism and the politics of conflict. It may require a movement of people acting in faith and with love, it may need us to move away from difference and towards unity.

Jan Arriens built on this introduction by explaining what the Quaker Truth and Integrity Group are practically doing to promote a better kind of politics. They in particular want to shine a light on the good and bring back truth and integrity to centre stage. In this endeavour, they have developed a Declaration <a href="https://quakertruth.org/declaration/">https://quakertruth.org/declaration/</a> that they hope people will send to their own MP. They urge people to write to their MPs, other elected representatives, and others in public life, commending them whenever they act with integrity. QTIG wants to promote a more participative democracy and constitutional reform that will allow for MPs to be more responsive to the needs of their constituents rather than other vested interests. They also want to promote higher standards of truth telling in the media. To these ends, they have also introduced an Award for an individual who makes a marked impact with their standard of honesty and integrity. Do people have possible nominees to suggest (see <a href="https://quakertruth.org/truth-award/">https://quakertruth.org/truth-award/</a>)?

The Quaker Truth and Integrity Group want in particular to work with other faith groups, and beyond, to promote better standards in public life – both promoting greater awareness of, and building up more respect for, the Nolan Principles. In the discussion that followed, there were exchanges on the adversarial parliamentary system (even the architecture of the House of Commons that does not encourage bi-partisanship); the first-past-the-post electoral system; the whipping system - all of which contribute in different ways to the polarised positions taken by our politicians. Several examples were given of other groups that might be interested in supporting QTIG's Declaration, learning about the Award, making combined statements and developing common programmes of work – for example the Catholic Union of Great Britain, Christians in Politics, More in Common, Hope not Hate, Together for the Common Good etc. CAFOD (and other such groups)also have 'Parliamentary Correspondents' etc. who could be alerted to the Nolan Principles and the work of QTIG in the course of their campaign efforts.

In smaller group discussions, some of these issues were brought further forward since everyone seemed to agree with the initial question – they were all very worried about the standards of honesty and integrity in public life. Participants discussed issues such as: the importance of challenging untruths; the need to get the facts out and explain underlying problems (eg to counter misinformation about migrants and refugees); an awareness that the promotion of justice (more than charity) requires advocacy and 'good' politics; the importance of education (in schools, and indeed in seminaries) about the values we require of public service; is it enough for the MP to be sincere or how do we ensure that they have accurate information for policy making; the need to discuss issues rather than labels and reality; the value of faith groups using their voting power to assert good values; the importance of the (Catholic) hierarchy thinking more strategically and 'outside of the box' in promoting greater truth and integrity in our politics; the need to recognise that integrity in public life requires change (and formation) not only in our elected representatives but also in the electorate; the value of hope and looking for it in ourselves and others; the need to promote that human values and human dignity should be at the heart of any faith initiative, thus avoiding misguided claims of "being too political"; the need to work on an ecumenical basis to promote some of these principles more effectively.

There was general agreement to a statement to be proposed to the Network executive proposing continued cooperation between the NJPN and QTIG.

# THE BALFOUR PROJECT

# Aim: Peace, justice and human rights in Palestine/Israel.

In November 1917 the government of Britain issued the Balfour Declaration which promised a homeland for the Jewish people in Palestine whilst also promising to protect the rights of the existing indigenous Arab population. However, in 1915 Britain had already promised the Arabs who supported them against the Ottomans, that after the war they would be granted independence in their lands, including Palestine.

Subsequent British governments upheld the promise to create a Jewish homeland but deliberately reneged on the promise to protect the rights of the Arab inhabitants. Thus, a homeland for the Jewish people has been achieved but the League's 'Sacred

Trust of Civilisation' to facilitate Palestinian independence is still to be fulfilled. Over a hundred years ago, the stage was set for a struggle to control the land that has intensified from that day to this.

# **Our Mission Statement:**

Acknowledging Britain's historic and continuing responsibilities, we work through education and advocacy to advance equal rights for all in Palestine/Israel, regardless of race or creed. We raise public awareness of the issue in Britain. We seek to persuade our Parliament and Government to demand that the rule of law and fundamental human rights, including the right to self-





# AL- ANON

Marian Thompson writes: I am sure we know of Alcoholics Anonymous (AA) and the excellent work they do. But I am ashamed to say that I did not know about Al-Anon until a member of a local group came to talk to our Churches Together quarterly meeting last week. He was aware that many people did not know about Al-Anon and asked us to publicise their work. The drinking of every alcoholic affects about 20 other people: a partner, family, friends, work colleagues. Where as AA is fairly well known and very helpful to the alcoholics themselves, others affected tend to be overlooked and forgotten. Al- Anon is an organisation specifically for them offering help and support through a website, helpline and meetings. All meetings are free and open to anyone affected by someone's drinking where people can share experiences and offer each other support often exchanging phone numbers. Al-Anon is non affiliated, non religious. There are about 700

groups in the country and I heard there has been one in Marple for sometime. Members' identity is protected. Al-Anon teaches that alcoholism is a disease, a complex, progressive disorder that causes physical, mental, spiritual and financial problems leading to anxiety, anger and denial for alcoholics and their family and friends. Al-Anon doesn't give advice but encourages people to focus on themselves – self care and self esteem are important as people closely connected with alcoholics are often damaged themselves by the experience. They follow a 12 step programme similar to AA which can lead to self knowledge, help with recovery and acceptance of the situation. Al-Anon is funded by donations. Our speaker explained how he became involved when having to cope with an alcoholic partner. He asked if we could help get the organisation better known particularly to those who were needing help.
